TCMA News

from staff reports

Editor's note: Here in a nutshell is the latest Texas Cave Management Association news.

\*\*\*\*\*

Progress appears slow but sure in the TCMA's efforts to acquire a 3.6-acre tract of land in South Austin. Board member Jay Jordan has been involved for the past four or so months in negotiations with a property management company in Dallas which is in charge of contract administration regarding the property on behalf of the Federal Deposit Insurance Corp.

The tract contains Lost Oasis Cave, which is gated\* The cave has a large room and blows a considerable quantity of air. It is located next to a subdivision project and a junior high school which is under construction.

The TCMA board on June 11, 1992 had voted to enter into a contract with NationsBank, through the FDIC, for purchase of the land which includes the cave. Mike Warton, Austin caver and TCMA board member, had installed an excellent gate on the cave, and a fence encloses the adjacent land inside a compound.

Since that time, negotiations have revolved around the proposed purchase and sale agreement, which spells out rights and obligations of the purchaser and seller. Specifically, the seller has proposed that certain closing

costs -- recording fee, escrow fee, etc. -- be paid by TCMA. Also, the seller has proposed that it not pay for a new survey and title policy, but instead supply the buyer with the latest survey notes, from September 1991, and title commitment from March 1992.

The management company is working to provide documents for a closing in Austin later in December, with the TCMA to be represented by Carl Ponebshek, chairman of the board. The TCMA has requested a closing before the end of the tax year, and argued that time is of the essence.

More news will be provided as it becomes available.
